Dual Enrollment Admissions Application

Dual Enrollment admissions @SCF enables qualified public, private, and home high school education students to enroll in selected college credit courses offered by SCF. The credits that they earn count towards both a college degree and a high school diploma.

Students who have questions about the Dual Enrollment program should consult their high school counselor/official prior to starting the application.


Students **must complete** the entire application in one sitting. Do not exit the application. The application will take no more than 15 minutes to complete. Please have your social security number ready.

Dual Enrollment admissions applications remain active for three terms or one academic year. Once an application is inactivated, students are notified by SCF that they are required to reapply if they choose to take courses after the inactivation occurs. If you have not been notified there is no need for you to complete an additional admissions application. For more information on your application, please contact the SCF admissions office.


