Notes: Vice-Chair Spray spoke regarding the CFOC's Annual Report from the previous year. She expressed interest in incorporating letter grades per school in the Committee's Annual Report.

The Committee held discussion and asked questions.

Mr. Kennedy provided information regarding test scores and school grades from the Department of Education (DOE).

Following a question from Ms. Fredricksen, the Committee discussed instructional staff retention data.

Chair Ballard joined the meeting virtually at 2:15 PM.

Vice-Chair Spray suggested adding instructional staff retention data to the next agenda. Ms. Barber agreed to follow up on the information.

Mr. Bargeron stated that during the last couple weeks he had met with the two liaisons, Ms. Fredricksen for Data Analytics and Vice Chair Spray for Income and Deployment. He spoke regarding the work the internal teams had done and asked which data the Committee wants tracked. He spoke in support of consistency.

Vice-Chair Spray further discussed the Report and noted topics that she would like expanded.

Ms. Barber stated that it is important for the community to see the same template of the Report so they can see consistent information. Ms. Harrigan agreed. The Committee held discussion and asked questions regarding the consistency of the Annual Report template and measurable data. Ms. Holley suggested the Committee select a template.

The Committee held discussion regarding whether or not keep the same consistent template or add more measurable data.

Ms. Howell joined the meeting virtually at 2:52 PM.

Mr. Bargeron stated that he would share the DOE publication 2021 Guide to Calculating School Grades and District Grades.

Chair Ballard left the meeting at 3:15 PM.

Ms. Holley informed Vice-Chair Spray that she had a motion in regard to the template.

<u>Motion:</u> Ms. Holley made a motion to retain the template as presented on page 7: number of schools by letter grades and presented with a brief explanatory note that anyone reading the report can go to the School District Website or DOE Website to ascertain detailed information about each school in the District. The motion was seconded by Ms. Barber.

<u>Motion:</u> Mr. Stamm motioned to table the motion. The motion failed for lack of a second.
