It is my intent that my student will take one or two classes of FLVS or MVS during the 2025-2026 school year. I will register my student in FLVS or MVS prior to turning in this form. This form must be submitted by July 28th for DMJ to potentially accommodate this request. The school will only grant this request if it fits within the 2025-2026 master schedule.

Students who wish to enroll in a virtual education option on a part-time basis may choose to do so through either MVS or FLVS (see criteria above). This program allows students enrolled in public school or home school to take a portion of their coursework online for the purposes of **acceleration, grade forgiveness or credit recovery**. Zoned school students may participate in this program by taking any portion of their coursework online and at school (up to a total of 2 courses).

Policies for Part-time Programs: **1.** A student may not be placed in the same course concurrently at a district middle or high school and at Florida Virtual School. **2.** Schools may not deny placement in a course offered through Florida Virtual School even if the school offers the same course. **3.** A student who withdraws or is withdrawn from a virtual course within 28 days of entry must enroll in enough courses at the zoned school to maintain full-time enrollment status. **4.** 8th grade students who are enrolled in a virtual program for an academic course must complete the academic course by the last day of school or will be placed in an alternative instructional setting.

The following items must be met for this to be considered for approval:

1. I will provide on organization letterhead the days and times my student will have practices and games that require my student to leave early from school and take a virtual class. This letter must be signed by an official within the organization.
2. If you are requesting MVS/FLVS for something other than sports, we will need a letter stating the reasoning and it will need to be approved by the principal.
3. I also agree to submit an MVS/FLVS progress report every **four** weeks showing that my student is still enrolled in MVS/FLVS and passing the course or DMJ can revoke my student's virtual instruction.
4. Students must be actively enrolled in MVS/FLVS class equal to the number of periods they are off campus for the entire year or DMJ can revoke my student's virtual instruction. If they are taking a semester course the course must be finished by December and another course must be registered for the 2nd semester.
5. My student will be leaving school prior to the end of the normal school day, and it is my responsibility to pick up my student at the designated time or DMJ can revoke my student's virtual instruction.
