 - "Lagging data:" All testing (ELA, Benchmark, FSA, etc.) from quarter one to gauge the grade of the school for the following year
 - Scores are lower than we would like it, but middle schools are pushing for students to test in middle school and then the few leftovers are testing in high school which can affect the grade
 - "Testing pool and math" create the grade game that shows the projections
