

PALMETTO HIGH SCHOOL (PHS) PARKING APPLICATION 2020-2021

**There are some important changes for this year in purchasing your parking pass so please read carefully.*

- *You can print off the application found at the end of this packet or pick one up in front of the PHS office.*
- *Applications must be returned, by 3pm on August 12th if you want a senior spot.
Underclassman can also drop off applications to ensure that you get a spot.*
- *You only need to drop off your application, no payment is due at this time. Students will pay when they actually receive their parking pass (date TBA)*
- *Senior parking will be decided by a lottery. When all the applications are turned in, the team will randomly select 83 senior's applications. Those seniors will then be allowed to pick their spot on a selected day*
- *When we process your application, we will check with Ms. Fabiano for any fees or fines that have been issued to you.*
 - *If you owe money, you must make sure you pay before we will honor your application. SENIORS, you will not be entered into the lottery for a Senior Spot if you have any outstanding balances.*
- *Please make sure we can read your cell phone number on the application as we may need to call you during the processing procedure.*

LIMITED QUANTITY

PLEASE READ CAREFULLY, YOU WILL SIGN APPLICATION ACKNOWLEDGING THE RULES OF PARKING ON CAMPUS.

Student parking at PHS is a privilege, not a right! Parking space on campus is extremely limited.

QUALIFICATIONS:

To qualify for a parking permit you must present:

Completed parking application signed by STUDENT and PARENT/GUARDIAN and MEDIA CENTER.

1. Valid operator's driver license (no learners permits)
2. Current vehicle registration and Current insurance card.
3. **No outstanding school debt. Signature required from media center.**

REVOCACTION:

Revocation of parking privileges can occur for the following reasons:

1. **Having unexcused absences and/or skipping class.**
2. Excessive Tardiness to school (more than 3 per quarter)
3. Leaving campus without authorization, with or without other students
4. Continuous parking violations and/or driving violations before, during, or after school hours.
5. Loitering in vehicle or parking areas before, during or after school
6. **Tampering with other vehicles on school property any time will result in criminal and administrative actions.**
7. Tampering or damaging gates (Will also result in suspension and criminal charges with restitution).
8. Tampering or attempting to remove a boot from a vehicle will result in a replacement fee of the vehicle restraint.
9. Revocation is not limited to these reasons and school administration has the right to revoke parking privileges from any student that interrupts on-campus school activities, including before and after normal hours.

PENALTIES:

1. 1st Offense no parking pass or parked in unauthorized area.
-- Vehicle will be ticketed. (\$15.00 fine)
2. 2nd Offense no parking pass or parked in unauthorized area.
-- Vehicle will be booted. (\$30.00 removal fee) PHS will not waive fee.
3. 3rd offense no parking pass or parked in unauthorized area
-- Administrative action (referral for defiance, loss of parking privileges)

MISCELLANEOUS:

1. **Senior parking is limited to 83 spots.** Senior applications will be entered into a lottery for a spot. When students are allowed on campus, they will pick their spot. We will post that date later. If you do not receive a senior spot, you will be given one in another section of the lot. Example: If 90 students apply for a senior spot, only 83 will receive a spot, the other 7 will be moved to underclass parking.
2. **ONLY the last 18 inches of Senior parking spots may be painted.** Anything larger will result in a loss of parking privileges if not rectified within 72 hours of notification.
3. Parking pass to be hung from rear view mirrors while on campus.
4. Students without parking permits MAY NOT park their vehicles on campus.
5. **Vehicles without PHS permit or parked outside of designated student areas are subject to notification of School Resource Officer, fine, and/or administrative action.**
6. Students must leave their cars as soon as they park. No loitering in cars permitted.
7. Students may return to their cars ONLY when leaving school at the end of the day or after going through proper procedures. Administrative permission is required to enter the parking lot during the school day.
8. Parking lot and vehicles parked on campus are subject to all rules prescribed by the district student code of conduct. Violations are subject to administrative actions. **Students will place all items, such as flags, magnets, and banners, inside the vehicle while on campus.**
9. To ensure the safety and protection of the student population, Florida law provides for the search of any vehicle on campus by the school administration.
10. There will be no refunds for parking decals. (Even if revoked by the SGA or administration)
11. Parking decals are non-transferable. The student and transferee will lose parking privileges.
12. Students should report any suspicious activity on campus and parking lot to the first staff member, they see.
13. **Students are responsible for the contents of their vehicle.**
